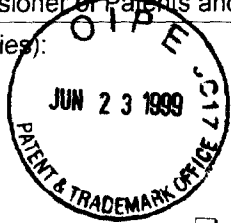



RECEIVING ORDER

UPON the Petition of Neil Cockcroft, of the City of Toronto, in the Province of Ontario,
a creditor, and upon the Petition of Construction Capital Corporation, a company incorporated
pursuant to the laws of the Province of Ontario, a creditor, filed the 5th day of December, 1997;

AND UPON reading the affidavits of Neil Cockcroft, sworn December 4th, 1997, and
on hearing submissions from counsel for the Petitioning Creditors, and upon reading the Notice
of Dispute and hearing submissions from the counsel for Frank Lacrosse;

AND IT appearing to the Court that the following act of bankruptcy has been committed:

- (a) Frank Lacrosse has ceased to meet his liabilities generally as they become due, including without limitation, payment to Neil Cockcroft and Construction Capital Corporation of the indebtedness due and owing by Frank Lacrosse to Neil Cockcroft and Construction Capital Corporation.

1. **IT IS ORDERED** that Frank Lacrosse, of the City of Waterdown in the Regional Municipality of Hamilton-Wentworth, Province of Ontario is adjudged bankrupt and a receiving order is hereby made against Frank Lacrosse.

2. **IT IS FURTHER ORDERED** that Arthur Andersen & Co., of the City of Toronto, in the Municipality of Metropolitan Toronto, Province of Ontario, is appointed as trustee of the estate of the bankrupt.

3. **IT IS FURTHER ORDERED** that the trustee shall forthwith give security in cash or by bond in accordance with subsection 16(1) of the *Bankruptcy and Insolvency Act*.

4. IT IS FURTHER ORDERED that the costs of and incidental to this Petition and Order shall be paid to the petitioners out of the estate of the bankrupt upon taxation thereof.

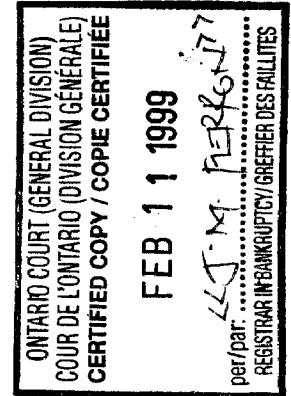
