and also in each and every country foreign to the United States of America, the same to be held and enjoyed by the ASSIGNEE for its own use and behoof, and for the use and behoof of its successors, its assigns or other legal representatives.

I hereby authorize and request the Commissioner of Patents, or other national or international patent authorities, to issue any and all Letters Patent on said invention or resulting from said patent or its application directly to the aforesaid ASSIGNEE.

I herewith authorize the aforesaid ASSIGNEE and its assigns, heirs and successors to apply for patent directly in its own name, upon the aforesaid invention and wherever the same is permitted by law, and I also assign, sell, transfer and set over unto said ASSIGNEE and its assigns, heirs or successors, all priority rights under the aforesaid patent and its application.

I further covenant to execute all additional instruments and to do all things necessary for carrying out the purpose of this instrument, at the expense of ASSIGNEE and its successors.
