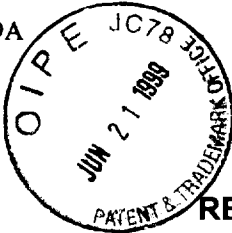

**WHEREAS**, We, MICHAEL MARIA STROBEL, a citizen of Germany residing at AM WEINBERG 2, D-85072 EICHSTÄTT, GERMANY, and RUDOLF BECKER, a citizen of Germany residing at JULIUS-LEBER-STRASSE 8, D-85057 INGOLSTADT, GERMANY (hereinafter referenced as ASSIGNORS), have invented a certain new and useful invention entitled A STRETCH MACHINE WITH A DRIVE MECHANISM WHICH IS HOUSED IN A DRIVE ENCLOSURE, for which an application for Letters Patent of the United States has been filed in the United States Patent and Trademark Office;
