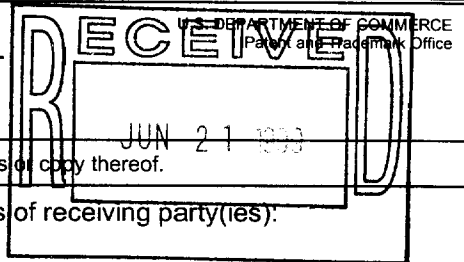

ASSIGNMENT

WHEREAS, I, Bernard Gerald Harter of 304 Cherry Street, Lynnville, Indiana 47619, together with Cary Lee Brown of 5001 Northlake Drive, Evansville, Indiana 47715; Richard E.
