

3 — The articles of the above-named corporation are amended as follows:

- b. to include the following standard private company restrictions:
  - i. the number of shareholders of the Corporation exclusive of persons who are in its employment and exclusive of persons who, having been formerly in the employment of the Corporation, were, while in that employment, and have continued after termination of that employment to be, shareholders of the Corporation, is limited to not more than fifty, two or more persons who are the joint registered owners of one or more shares being counted as one shareholder;
  - ii. no invitation shall be made to the public to subscribe for any securities of the Corporation; and
  - iii. shares of the Corporation shall not be transferred without the approval of the Board of Directors, such approval which is to be evidenced by a resolution of the Board.
