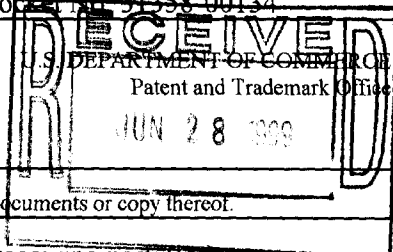

VACUUM FORMED COATED FIBROUS MAT
