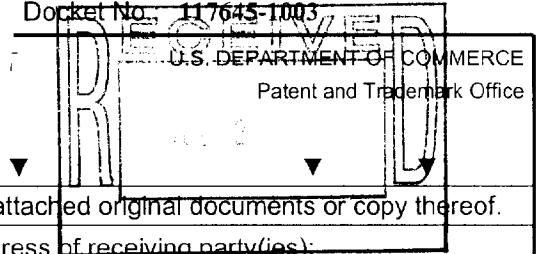

WHEREAS, I, Thomas J.
