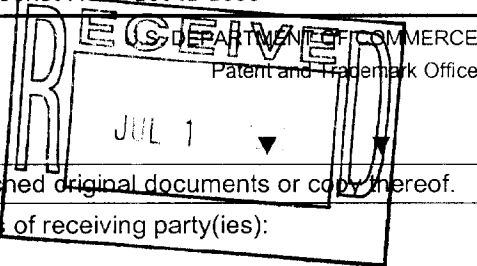

ASSIGNMENT

WHEREAS, I, Mark A. Ritter, am a citizen of the United States of America and resident of Garland, Texas, have invented certain new and useful improvements in a "AIR ASSISTED COLLATOR" for which I have made application for United States Letters Patent, the said application being identified as serial number 08/883,843 filed June 27, 1997, and;

WHEREAS, Dallas A.C. Horn & Co., d/b/a A.C. I hereby further agree that I will communicate to said ASSIGNEE, or to its successors, assigns and legal representatives, any facts known to me respecting any improvements; and, at the expense of said ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, and make all lawful oaths, and generally do everything possible to vest title in said ASSIGNEE and to aid said ASSIGNEE, its successors, assigns and legal representatives to obtain and enforce proper protection for said invention in all countries.

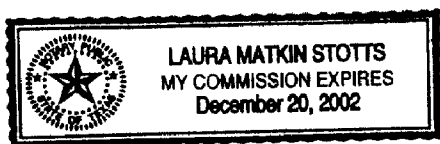
