



Assignment of Invention

WHEREAS, I, BAO HA, have invented certain new and useful improvements in CRYOGENIC DISTILLATION SYSTEM FOR AIR SEPARATION, for which an application for Letters Patent Serial No. U.S. 09/317,994, was executed on May 25, 1999; and

WHEREAS, AIR LIQUIDE PROCESS AND CONSTRUCTION, INC., (hereinafter referred to as "ASSIGNEE") having a place of business at 2700 Post Oak Blvd., Ste. 1800, Houston, Texas 77056, U.S.A. desires to acquire from BAO HA the entire right, title and interest that he has in and to said invention and in and to any Letters Patent that may be granted thereof in the United States and its territorial possessions;

Further, I agree that I will communicate to said ASSIGNEE or its representatives any facts known to me respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitute, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said ASSIGNEE, make all rightful oaths, and, generally do everything possible to aid said ASSIGNEE, its successors and assigns, to obtain and enforce proper protection for said invention in the United States and its territorial possessions.

The undersigned hereby grant(s) authorized representatives of the above identified ASSIGNEE(S) the power to insert on this assignment any further identification which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.
