WHEREAS I, **Peter K. Moldovan**, Cascade, in the County of Sheboygan, State of Wisconsin have invented certain improvements in:


ELECTRIC CURRENT SWITCHING APPARATUS HAVING AN ARC EXTINGUISHER WITH AN ELECTROMAGNET


