PATENTASSIGNMENT

WHEREAS, I, John C. Greene, of the City of Greensboro, State of North Carolina, (hereinafter "Assignor"), have invented certain new and useful improvements in METHODS AND SYSTEMS FOR SECURELY COMMUNICATING PERSONAL IDENTIFICATION NUMBER INFORMATION BETWEEN A SECURITY MODULE AND A PLURALITY OF SECURE KEYPAD DEVICES, for which I make application for Letters Patent of the United States.

AND, WHEREAS, Gilbarco, Inc., a corporation duly organized and existing under the laws of the State of North Carolina, having its principal office and place of business at Greensboro, North Carolina (hereinafter "Assignee"), is desirous of acquiring an interest therein.

Assignor hereby requests that said Letters Patent be issued in accordance with this assignment.

Assignor further covenants and agrees that, at the time of the execution and delivery of these presents, Assignor possesses full title to the invention and application above-mentioned, and that he has the unencumbered right and authority to make this assignment.

Assignor further covenants and agrees, and likewise bind his heirs, legal representatives and assigns, to promptly communicate to said Assignee or its representatives any facts known to them relating to said invention, to testify in any interference or legal proceedings involving said invention, to execute any additional papers which may be requested to confirm the right of the Assignee, its representatives, successors and assigns to secure patent or similar protection for the said invention in all countries and to vest in the Assignee complete title to the said invention and Letters Patent, without further compensation, but at the expense of said Assignee, its successors, assigns and other legal representatives.
