Kielwasser, who resides at 369 Brush Hill Road, Middletown, Connecticut 06457, have made certain inventions and discoveries relating to an automatic hog splitter as shown in Jarvis Drawing No. 4004199 and related drawings and as described in my technical description dated September 9, 1998 entitled "Jarvis Automated Hog-Splitting Saw" and which may be further described in an application for Letters Patent of the United States of America incorporating related disclosures and inventions by me.

4. 5. Bind my heirs, legal representatives and assigns, as well as myself, to do, upon Assignee's request and at its expense, but without additional consideration to me or them, all acts reasonably serving to assure that the said inventions and discoveries,


