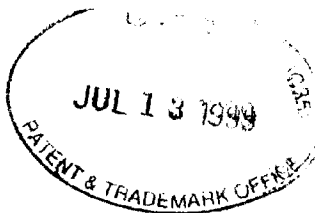

ASSIGNMENT

Whereas, We, NORBERT FISCHER of Osterkampsweg 18, 31319 Sehnde, Federal Republic of Germany, and ROLAND ALTSINGER of Barnackersweg 10c, 31303 Burgdorf, Federal Republic of Germany, have invented certain new and useful improvements in Method and Arrangement for Making Contactless Distance and Pressure Measurements within an Air Spring for which application for United States Letters Patent has been executed on even date herewith, (said application having Attorney Docket No. 98-041); and,

Whereas, CONTITECH LUFTFEDERSYSTEME GMBH, a corporation organized and existing under the laws of the Federal Republic of Germany, having its principal office at Philipsbornstrasse 1, 30165 Hannover, Federal Republic of Germany (hereinafter referred to as CONTITECH), is desirous of obtaining Letters Patent for said invention in the United States;

We agree for ourselves and for our heirs, executors and administrators to communicate to said CONTITECH, its successors, assigns, nominees or other legal representatives, all facts known to us respecting said improvements, whenever requested, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and do all

lawful acts requisite for the application, for such divisional, continuing or reissue applications or the procuring thereof, and we further covenant and agree that we will, at any time upon request, do everything legally possible to aid said CONTITECH, its successors, assigns, nominees or other legal representatives, either in its or their own name, to maintain and enforce any patent for said improvements without further consideration but at the expense of said CONTITECH, its successors, assigns, nominees or other legal representatives.

We hereby authorize and request the United States Commissioner of Patents and Trademarks to issue any and all Letters Patent which r granted upon any of said applications, to said CONTITECH as t^r Assignee of the entire right, title and interest in and r for its sole use and behoof; and for the use and behc successors, assigns, nominees, or other legal represent full end of the term for which said Letters Patent may be
