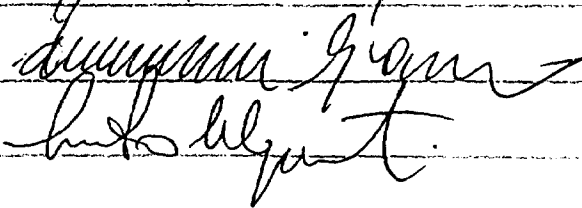

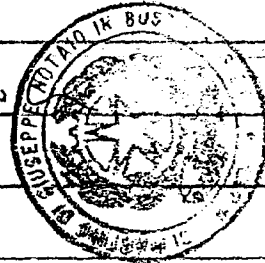

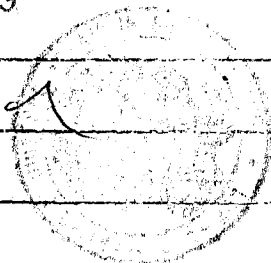

representative, having the necessary powers as provided
by the company's statute in force, Mr. MAZZACURATI
ERNESTO, born at San Giovanni in Persiceto (BO) on August
2, 1948, domiciled for office with the company's
registered office as above;

hereinafter called the "ASSIGNEE";

W H E R E A S

- the ASSIGNOR is the owner of the following patents and

3) The ASSIGNOR gives assurance that he has the full possessory title and availability of that which is involved in the present deed and that the same is clear from obligations and rights belonging to third parties. In connection with Law No. 151 of May 19, 1975, the ASSIGNOR states that he is married and that his marriage is based on separation of property.

Expenses and duties of the present Deed and consequent formalities are to be paid by the ASSIGNEE.

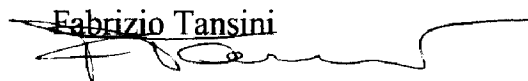

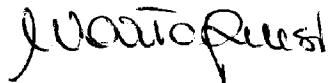
