# ASSIGNMENT OF UNITED STATES PATENT APPLICATION

WHEREAS, we, **Hong Tang** of Suwanee, Georgia; and **Yeming Gu**, of Suwanee, Georgia, have invented certain new and useful improvements in a **PRODUCE DATA COLLECTOR AND PRODUCE RECOGNITION SYSTEM**, Docket No. 8152, for which we have executed an application for Letters Patent of the United States on 6/23/99 and 6/23/99, respectively; and
