ASSIGNMENT

WHEREAS, WE, Adam K. Kolawa, Arthur Ray Hicken, Stephen Frankini, Skirmantas Kligys, Emelina Gesheshyen, Maxim E. Troukhan, residing at 673 Deadar Lane, Bradbury, California 91010; 1593 West 15th Street, Upland, California 91786; 2500 South 4th Avenue, Arcadia, California 91006; 250 South El Molina Avenue, #16, Pasadena, California 91101; 435 West Dryden Street, Apt. 17, Glendale, California 91202; 1675 Amberwood Drive, #2, South Pasadena, California 91030, respectively, have invented certain new and useful improvements disclosed in an application for United States Letters Patent entitled **METHOD AND APPARATUS FOR AUTOMATED SELECTION, ORGANIZATION, AND RECOMMENDATION OF ITEMS**, and executed by us on even date herewith;
