

## ASSIGNMENT

WHEREAS, ERICSSON INC. ("ASSIGNOR"), a corporation organized and existing under the laws of the state of Delaware, having its principal place of business at 7001 Development Drive, P.O. Box 13969, Research Triangle Park, North Carolina 27709, United States of America, (hereinafter referred to as "ASSIGNOR") is the sole owner of the entire interest in the invention for a SYSTEM NETWORK AND METHOD FOR THE TRANSFERENCE OF CELL HANDOVER INFORMATION by virtue of assignment recorded with the Assignment Branch of the U.S. Patent and Trademark Office on March 26, 1999, beginning at Reel 9847, Frame 0414, for which an application for United States Letters Patent was made on August 19, 1998; and

WHEREAS, TELEFONAKTIEBOLAGET LM ERICSSON (publ) ("ASSIGNEE"), a corporation organized and existing under the laws of Sweden, having its principal place of business at S-164 80, Stockholm, Sweden, (hereinafter referred to as "ASSIGNEE"), is desirous of acquiring the entire right, title and interest in and to the invention, and in and to the said application and any Letters Patent that may issue thereon.

NOW, THEREFORE, in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby assigns unto ASSIGNEE, its successors, assigns and legal representatives, ASSIGNOR'S entire interest in said invention and in said application and all patents which may be granted therefor, and all

divisions, reissues, substitutions, continuations, continuations-in-part and extensions thereof. ASSIGNOR hereby authorizes and requests the Commissioner of Patents and Trademarks to issue all patents for said invention, insofar as ASSIGNOR'S interest is concerned, to the said ASSIGNEE.

ASSIGNOR also hereby assigns to said ASSIGNEE, its successors, assigns and legal representatives, the full and exclusive interest in the invention disclosed in said application throughout the world, including the right to file applications and obtain patents, utility models, industrial models and designs for said invention in its own name throughout the world, including all rights of priority, all rights to publish cautionary notices reserving ownership of said invention and all rights to register said invention in appropriate registries.



At the expense of said ASSIGNEE, ASSIGNOR agrees to testify in any legal proceedings; sign all lawful papers; execute all divisional, continuation, continuation-in-part, reissue, and substitute applications; make all lawful

oaths; and generally do everything possible to vest title in said ASSIGNEE and to aid said ASSIGNEE, its successors, assigns and legal representatives to obtain and enforce proper protection for said invention in all countries.
