And, I the said Assignor further covenant and agree that Assignor will at any time, upon request, execute and deliver any and all papers that may be necessary or desirable to perfect the title of said invention, or any Letters Patent that may be granted therefor to the Assignee, its successors, assigns or other legal representatives and that if the Assignee, its successors, assigns or other legal representatives desire to secure a reissue, division, or extension of said Letters Patent, Assignor will upon request sign all papers, make all rightful oaths, and do all legal acts necessary and requisite for the application of such reissue, division or extension and the procuring thereof, and generally do all other and further lawful acts deemed necessary or expedient by the Assignee to assist or enable the Assignee to obtain and enforce full benefits from the rights and interests herein assigned, but at the expense of the Assignee.
