## ASSIGNMENT OF PATENT APPLICATION

WHEREAS, the undersigned, Michael Truong, a resident of 3190 Yakima Circle, San Jose, California 95121 (hereinafter referred to as Assignor) has invented certain new and useful improvements in an invention entitled DEVICE AND METHOD OF SEATING AND UNSEATING A LID FROM A CARRYING CASSETTE, presently identified as Attorney Docket No. HSQ-012, for which an application for a United States Patent was executed on July 1, 1999.



3. The terms, covenants and conditions of this assignment shall inure to the benefit of said Assignee, its successors, assigns and/or other legal representatives, and shall be binding upon said Assignor, his heirs, legal representatives and assigns.

4. Said Assignor hereby warrants and represents that he has not entered into any assignment, contract or understanding in conflict herewith.


