

## **ASSIGNMENT**

WHEREAS, I, Wolfgang Fabian, residing at Relaisstrasse 183, 68219 Mannheim, Germany, have invented certain new and useful improvements in a **Faucet** for which I have executed an Application for Letters Patent of the United States on April 14, 1999 and identified as U.S. Serial No. 29/103,415;

AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith;

AND I HEREBY further covenant and agree that I will communicate to the ASSIGNEE, its successors, legal representatives and assigns, any facts known to me respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.
