Under Section 803 of the Not-for-Profit Corporation Law

The undersigned Patrick E. Brown, Esq., attorney-in-fact for NORTH SHORE

UNIVERSITY HOSPITAL RESEARCH CORPORATION (the "Corporation") hereby certifies
that:

- A. The name of the Corporation is NORTH SHORE UNIVERSITY HOSPITAL RESEARCH CORPORATION.
- B. The Certificate of Incorporation of the Corporation was filed by the Department of State on December 1, 1983 pursuant to Section 402 of the Not-for Profit Corporation Law.
- C. The Corporation is a corporation as defined in subparagraph (a)(5) of Section 102 (Definitions) of the Not-for-Profit Corporation Law and is a Type B corporation under Section 201 (Purposes) of the Not-for-Profit Corporation Law. After the filing of this Certificate of Amendment, the Corporation shall remain a Type B corporation under Section 201 (Purposes) of the Not-for-Profit Corporation Law.

D. The Corporation hereby amends Paragraph First of the Certificate of Incorporation which relates to the name of the Corporation and changes the name of the Corporation from NORTH SHORE UNIVERSITY HOSPITAL RESEARCH CORPORATION to North Shore-Long Island Jewish Research Corporation. Paragraph First of the Certificate of Incorporation shall read in its entirety as follows:

The name of the Corporation is North Shore-Long Island Jewish Research Corporation.

E. The Corporation hereby amends Paragraph Third of the Certificate of Incorporation which relates to the purposes of the Corporation and adds Long Island Jewish Medical Center as a hospital that is named in the Certificate of Incorporation as a hospital in conjunction with which the Corporation conducts medical research. Paragraph Third of the Certificate of Incorporation shall read in its entirety as follows:

The purposes for which the Corporation is formed are to cardiuct direct continuous active medical research in conjunction with North Shore University Hospital, a voluntary not-for-profit hospital corporation organized and existing under the laws of the State of New York and located in Manhasset, Town of North Hempstead, Nassau County, New York, Long Island Jewish Medical Center, a voluntary not-for-profit hospital corporation organized and existing under the laws of the State of New York and located in New Hyde Park, Queens County, New York and other voluntary not-for-profit hospital corporations which are affiliated with North Shore University Hospital and Long Island Jewish

Medical Center. As used herein, "medical research" means investigations, experiments and studies to discover, develop or verify knowledge relating to the causes, diagnosis, treatment, prevention or control of the physical or mental diseases and impairments of

F. The Corporation hereby amends Paragraph Twelfth of the Certificate of Incorporation which relates to the service of process address and changes the name of the entity at the post office address to which the Secretary of State shall mail a copy of any process against

the Corporation from North Shore University Hospital Research Corporation to North Shore-

Long Island Jewish Research Corporation. Paragraph Twelfth of the Certificate of Incorporation

shall read in its entirety as follows:

The Secretary of State is hereby designated as agent of the Corporation upon whom process against it may be served. The post office address to which the Secretary of State shall mail a copy of any such process against the Corporation served upon him is: North Shore-Long Island Jewish Research Corporation, 350 Community Drive; Manhasset, New York 11030.

Incorporation which relates to the name of the sole member of the Corporation and changes the name of its sole member from North Shore Health System to North Shore-Long Island Jewish Health System, Inc. Paragraph Fourteenth of the Certificate of Incorporation shall read in its entirety as follows:

The Corporation shall be a membership corporation. The sole member of the Corporation shall be North Shore-Long Island Jewish Health System, Inc., a not-for-profit corporation organized and existing under the laws of the State of New York.

H. This Amendment of the Corporation's Certificate of Incorporation was authorized by a vote of the sole member of the Corporation in accordance with Section 802 of the Not-for-Profit Corporation Law of the State of New York.


