WHEREAS, Jeffrey A. Haight, County of Hendricks, State of Indiana, hereinafter called the "Assignor", has invented certain new and useful improvements in a TAPERED BUSHING FOR A ROLLER CHAIN for a full description of which reference is here made to an application for Letters Patent of the United States identified as attorney's Case No. 6189, executed of even date herewith; and


Assignee, its successors, assigns and legal representatives, to the full end of the term or terms for which any and all of said Letters Patent for said invention may issued.


