

## ASSIGNMENT OF PATENT APPLICATION AND INVENTIONS

WHEREAS, WRIGHT EQUIPMENT COMPANY (PTY) LTD, a corporation organized under the laws of South Africa, having its principal place of business at 136 Main Reef Road, Boksburg North, South Africa (hereinafter "ASSIGNOR"), owns certain inventions and improvements disclosed in an application for Letters Patent entitled "GROUND ENGAGING TOOL COMPONENTS", filed in the United States Patent and Trademark Office on February 11, 1998 as Application No. 09/021,747; and in an application for Letters Patent entitled "GROUND ENGAGING TOOL COMPONENTS", filed in the United States Patent and Trademark Office on January 7, 1999 as Application No. 09/226,522; and

AND, for the same consideration, ASSIGNOR agrees to sign all lawful papers, execute all divisional, continuing, reissue and other applications, make all assignments and rightful

oaths, and generally do everything possible to aid ASSIGNEE, its successors, assigns, and nominees, to obtain and enforce proper protection for all said inventions and improvements in the United States.

ASSIGNOR further agrees that all necessary records of ASSIGNOR to establish priority of invention in any interference or similar proceeding will be made available at no additional charge to ASSIGNEE, in the event such records are needed in connection with any of the assigned Letters Patent or applications for Letters Patent.
