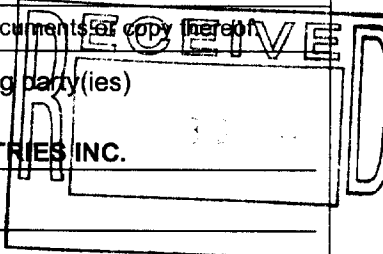


ASSIGNMENT


