

ORDER GRANTING APPLICATION FOR WRIT OF ATTACHMENT

On this day, the Court heard the application and affidavit of Benjamin Wright for a writ of attachment. After consideration of the Application and Affidavit, as well as the pleadings and other papers on file, the Court makes the following findings:

- 1. The application was filed after commencement of suit.
- The statutory grounds for granting the application exist, in that the 2. plaintiff will probably lose his debt unless the writ of attachment is issued, and:
 - the defendant has disposed of or is about to dispose of all or part of (a) its property with the intent to defraud its creditors; or
 - (b) the defendant is about to convert all or part of its property into money for the purpose of placing it beyond the reach of its creditors
- 3 The writ of attachment applies only to defendant's interest in any and all U.S or foreign patents, technology and know-how, including but not limited to US Patent No. 5,659,746, and all applications, continuations and other rights or proceedings related thereto (the "Attached Property").
- 4. The attachment is limited to a maximum property value of \$65,000.00.
- 5. The amount of bond required of the applicant is \$5000.00.
- 6. The amount of bond required of defendant to replevy is \$39,000.00

ORDER GRANTING APPLICATION FOR WRIT OF ATTACHMENT - Page 1

IT IS THEREFORE ORDERED, ADJUDGED, and DECREED that, upon filing the required attachment bond, the clerk of court shall issue a writ of attachment directed to any sheriff or constable within the State of Texas, commanding them to attach and hold, unless replevied, subject to the further order of the court, the Attached Property, and directing that the attached property be kept safe and preserved subject to further orders of the Court.

IT IS FURTHER ORDERED, ADJUDGED, and DECREED that, as one means of levying attachment on the Attached Property a copy of this Order and said writ be recorded in the records maintained by the U.S. Patent and Trademark Office concerning ownership, assignment, conveyance and grant of patents.
