THIS ASSIGNMENT made the 28 day of AUGUST 1997, by MIKE MC MAHON

WITNESSETH:

WHEREAS, I am the sole inventor of a certain new and useful improvement in MULTI-LINGUAL PORTABLE GRAIN MOISTURE METER for which I have executed an application for Letters Patent of the United States on the 28. Day of August 1997; and
