

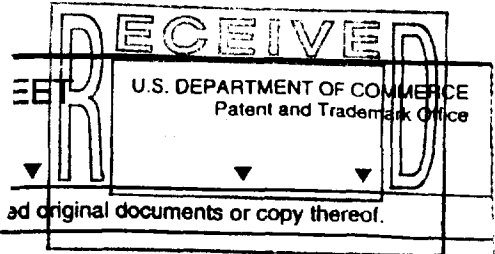

ASSIGNMENT AND AGREEMENT

FOR VALUE RECEIVED, I, Ogden R. Olson, a citizen of the United States of America residing at 2043 Mississippi View Drive, Muscatine, Iowa 52761, United States of America, hereby sell, assign and transfer to HON Technology Inc., a corporation duly organized and existing under the laws of the State of Iowa, and having its principal place of business at 414 East Third Street, Muscatine, Iowa 52761, as assignee, and its successors, assigns and legal representatives, the entire right, title and interest, for all countries in and to certain inventions relating to improvements in a CHAIR described in an application for Letters Patent of the United States, filed June 3, 1999 as application Serial No. 29/105,808, and all the rights and privileges under any and all Letters Patent that may be granted therefor.



I hereby consent that a copy of this assignment shall be deemed a full legal and formal equivalent of any assignment, consent to file or like document which may be required in any country for any purpose and more particularly in proof of the right of the said assignee or nominee to claim the aforesaid benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it.

I covenant with said assignee, its successors, assigns and legal representatives, that the rights and property herein conveyed are free and clear of any encumbrance, and that I have full right to convey the same as herein expressed.


