ASSIGNMENT

WHEREAS, WE, Oscar E. Agazzi; David Kruse; Arthur Abnous; and Mehdi Hatamian, residing at 38 Deerfield, Irvine, California 92606; 2401 Blackthorn Street, Newport Beach, California 92660; 460 Santa Barbara, Irvine, California 92606; and 25681 Pacific Hills, Mission Viejo, California 92692, respectively, have invented certain new and useful improvements disclosed in an application for United States Letters Patent entitled **MULTI-PAIR TRANSCEIVER DECODER SYSTEM WITH LOW COMPUTATION SLICER**, and executed by us on even date herewith;

AND WHEREAS BROADCOM CORPORATION, a California corporation, having a place of business at 16215 Alton Parkway, Irvine, California 92618 (hereafter, together with any successors, legal representatives or assigns thereof, called "ASSIGNEE") wants to acquire the entire right, title and interest in and to said improvements and application.
