ASSIGNMENT UNITED STATES PATENT

This Assignment made, executed on the date listed hereinbelow and effective the *Third*

day of April, 1997, by and between Carl H. Hoecherl an individual residing at 1031

Leith, Maumee, Ohio (hereinafter (HOECHERL) and Restle Decoy Company (hereinafter RESTLE) a Ohio corporation having a place of business in Maumee, Ohio and Northern Hydraulics, Inc. (hereinafter NORTHERN) , a Minnesota corporation, having a place of business in Burnsville, Minnesota.

RESTLE and HOECHERL assign to NORTHERN, its successors and assigns the right to bring or maintain suit at law and equity for past infringements of said PATENT and to retain fro the benefit of NORTHERN all damages or settlements arising from said past infringements of said PATENT

This Assignment is to be construed, interpreted. And applied in accordance with laws of the State of Ohio.
