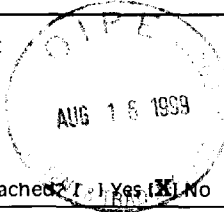

ASSIGNMENT

WHEREAS, we, Marc MARRIERE and Bruno LEVERRIER, hereafter referred to as "applicants", have invented certain new and useful improvements in **ELECTRIC HOUSEHOLD APPLIANCE FOR PROCESSING FOOD COMPRISING A DEVICE FOR STORING COOKING EQUIPMENT**,

(a) for which an application for a United States patent was filed on March 22, 1999, Application No. 09/254,958,
