I authorize Assignee to make application on its own behalf for design patent rights and rights of protection in countries foreign to the United States and where expedient to claim under international law or convention or the laws of any particular country (such as the International Convention for the Protection of Industrial Property) for any such application the date of the United States application as priority to such other application. I further authorize Assignee to claim under international law or convention or the laws of any particular country such priority rights without further written or oral authorization from me. I consent that a copy of this Assignment shall be deemed a full legal and formal equivalent of any assignment, consent to file or like document that may be required under international law or convention or the laws of any particular country for any purpose, including the right of Assignee to claim such priority rights.

I authorize and request the patent office officials in the United States and in countries foreign to the United States to issue the design patent rights to S-B Power Tool Company.
