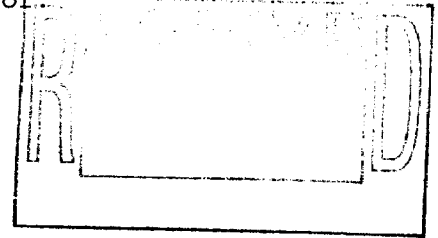

cause any and all of said Letters Patent to be issued to said ASSIGNEE, make all
rightful oaths or declarations and generally cooperate with said ASSIGNEE, its
successors and assigns, to obtain and enforce proper protection for said invention in
the United States and in any and all foreign countries. We authorize any of our


