

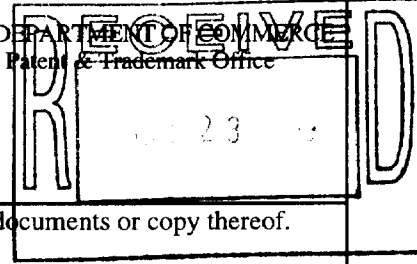

ASSIGNMENT
