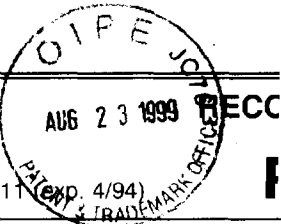



successors, assigns, and nominees, to obtain and enforce proper patent protection for said invention in all countries.


