I hereby authorize and request the Patent Trademark Office officials in the United States and its territorial possessions and any and all foreign countries to issue any and all of said Letters Patent, when granted, to said ASSIGNEE as the assignee of my entire right, title and interest in and to the same, for the sole use and behoof of the said ASSIGNEE, its successors and assigns.
