ASSIGNMENT BEFORE PATENT

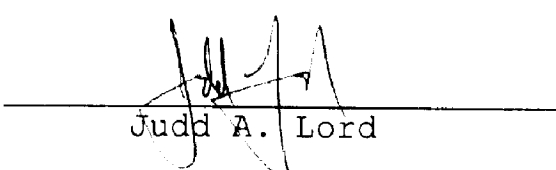

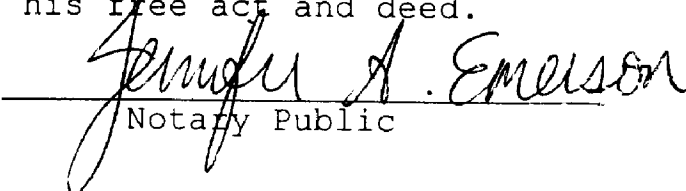
