

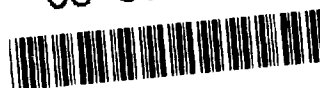

ASSIGNMENT BEFORE PATENT




