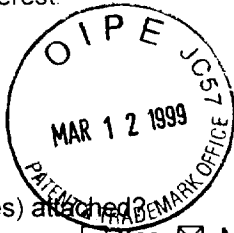

**ASSIGNMENT**

WHEREAS, David G. Quinn, hereinafter called the "Assignor", has made the invention described in the United States patent application entitled BOLSTER FOR CORPOREAL ACCESS TUBE ASSEMBLY, executed by Assignor on the same date of this Assignment;

WHEREAS, C.R. The Assignor hereby covenants and agrees, for both the Assignor and the Assignor's legal representatives, that the Assignor will assist the Assignee in the prosecution of the patent application identified above; in the making and prosecution of any other patent applications that the Assignee may elect to make covering the invention identified above; in vesting in the Assignee like exclusive title in and to all such other patent applications and



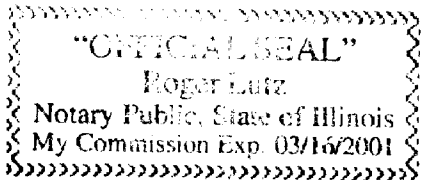
