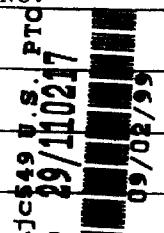

ASSIGNMENT OF INVENTION






