

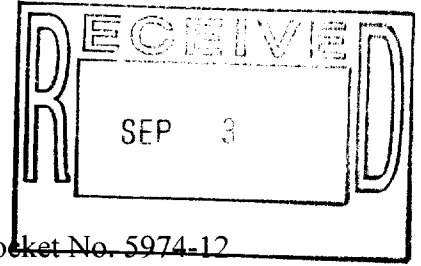

ASSIGNMENT
OF UNITED STATES PATENT RIGHTS

WHEREAS, I, Laurent Di Cesare (hereinafter collectively "Assignor" including Assignor's heirs, executors, administrators and legal representatives), citizen of France and residing, at La Ferte sous Jouarre, France, have invented one or more inventions (hereinafter referred to as "said invention(s)") disclosed in an application for Letters Patent of the United States titled **ADDING CODE IN AN APPLICATION DURING RUNTIME TO ENRICH OBJECT BEHAVIOR** having been filed on June 10, 1999 and given Application No. 09/327,729 (hereinafter referred to as "said application"); and

WHEREAS, DASSAULT SYSTEMES (hereinafter together with its successors and assigns referred to as "the Assignee"), a French company having a place of business at 9, quai Marcel Dassault, BP 310, 92156 Suresnes Cedex, France, is desirous of obtaining all right, title and interest in and to said invention(s) and said application in the United States of America;

Assignor hereby authorizes the Commissioner of Patents and Trademarks of the United States of America to issue all said Letters Patent to the Assignee as assignee of all right, title and interest therein or otherwise as the Assignee may direct, in accordance with this instrument of assignment.

Assignor hereby represents and warrants that there are no rights or interests outstanding inconsistent with the rights and interests granted herein, and that Assignor will not execute any instrument or grant or transfer any rights or interests inconsistent with the rights and interests granted herein, and Assignor agrees to execute and deliver to the Assignee any further documents or instruments and do any and all further acts that may be deemed necessary by the Assignee to file applications for said invention(s) in any country where the Assignee may elect to file such applications, and that may be necessary to vest in the Assignee the title herein conveyed or intended so to be, and to enable such title to be recorded in the United States of America.

And Assignor further covenants and agrees, in consideration of the premises, that Assignor will at any time upon request of the Assignee communicate to the Assignee any facts relating to said invention(s), and the history thereof, know to Assignor, and that Assignor will testify upon the request of the Assignee at the Assignee's expense as the case may be, as to the same in any interference or other litigation.
