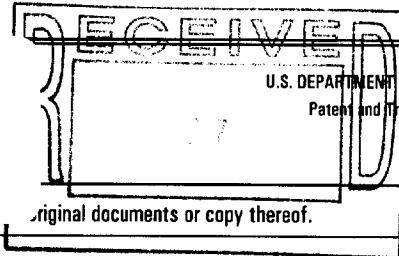


# ASSIGNMENT
