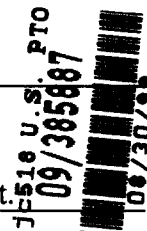

## ASSIGNMENT AND AGREEMENT




