WHEREAS, WE, ROBERT A. TYGAR, a resident of Budd Lake, New Jersey, and a citizen of the United States of America, STANLEY E. CHRAPOWICKI, a resident of Neshanic Station and a citizen of the United States of America, and ERIC S. BLASIC, a resident of High Bridge and a citizen of the United States of America, are co-inventors of new and useful improvements in BALL MOUNTING ARRANGEMENT IN A LAUNCHER, for which an application for United States Patent was executed by me on even date herewith;

successors and assigns, the same as it would have been held and enjoyed by us if this assignment and sale had not been made.

AND WE HEREBY authorize and request the Commissioner of Patents and Trademarks to issue all such Letters Patent to the said UNITED STATES GOLF ASSOCIATION in accordance with this instrument of Assignment.

WE FURTHER covenant and agree, in consideration of the premises, that we or our executors and administrators, will execute and deliver to the said UNITED STATES GOLF ASSOCIATION, its successors and assigns, any further documents or instruments, and do any and all further acts that may be deemed necessary by the said UNITED STATES GOLF ASSOCIATION, its successors and assigns, to file applications for the said improvements and invention in any country where it may elect to file such applications, and that may be necessary to vest in the said UNITED STATES GOLF ASSOCIATION, its successors and assigns, the title herein conveyed or intended so to be, and to enable such title to be recorded in the United States and foreign countries where such application or applications may be filed.
