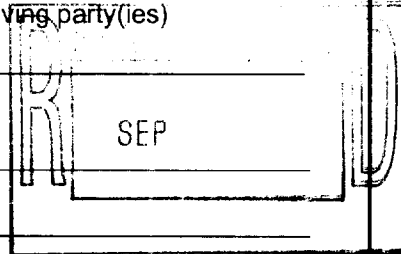

The undersigned hereby authorize and request the Commissioner of Patents to issue said Letters Patent to said Heska Corporation.


