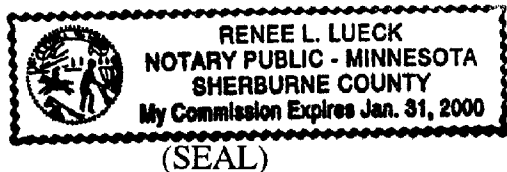
statutes, or regulations; said foreign applications to be filed and issued in the name of **IMI Cornelius, Inc.**, or its designee insofar as permitted by applicable law.


