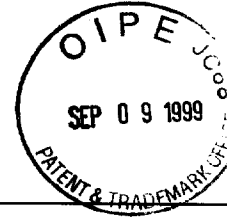

WHEREAS, WE, Robert V. O'KEEFE, Carl D. NEUBURGER and Franklin C. BRADSHAW, have invented a certain improvement in ADHESIVE TRANSFER DEVICE, for which a regular utility patent application is being filed herewith;

the said invention, and to execute any papers by the said assignee, its successors, assigns and legal representatives, deemed essential to the assignee's full protection and title in and to the invention hereby transferred;

Agreeing, furthermore, upon request of said assignee and without further remuneration, to execute any and all papers desired by the said assignee for the filing and granting of foreign applications and the perfecting of title thereto in said assignee.
