WHEREAS WE, Norman E. Blank and Hubert K. Schenkel, residing at Max-Reger-Str. 28, 6900 Heidelberg, Germany and Robert-Schuman Str. 19/1, 6902 Sandhausen, Germany respectively, have made an invention relating to HOT MELT ADHESIVE, which invention is described in an application for Letters Patent of the United States entitled: REACTIVE HOT MELT ADHESIVE and signed on _____, respectively; and filed in the United States Patent Office on June 26, 1991, under Serial No. 721,045; and

And each of us does hereby agree for himself and for his heirs, executors, and administrators to execute any lawful document and to testify as to any material fact or thing which TEROSON G.M.B.H., its successors or assigns, may deem necessary in order to secure unto itself, its successors and assigns, the full right, title, and interest in and to the full enjoyment of said invention or any part thereof and the said Letters Patent or any of them, the same to be done without any further consideration.
