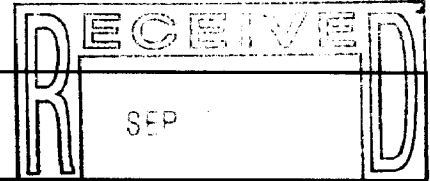



representatives, and shall inure to the benefit of Assignee, its successors, assigns and nominees.


