ASSIGNMENT



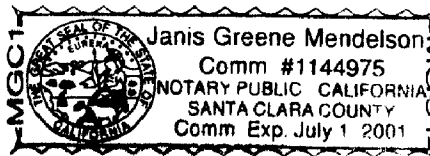
