ASSIGNMENT

WHEREAS, We, Stefano Folli, Alain Scherrer and Paolo Milimatti, citizens of Italy, Switzerland, respectively and residing respectively at Via Cattori 4, CH-6600 Locarno, Switzerland; Via del Tiglio 37, CH-6605 Locarno-Monti, Switzerland; and Via Remorino 4, CH-6648 Minusio, Switzerland, have invented certain new and useful improvements in **FASTENING SYSTEM FOR SHAFT INFORMATION TRANSMITTERS OF A LIFT INSTALLATION**, for which we executed an application for Letters Patent of the United States of America on even date herewith; and

foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said improvements to the said INVENTIO AG, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND WE HEREBY further covenant and agree that we will communicate to the said corporation, its successors, legal representatives and assigns, any facts known to us respecting said improvements, and testify in any legal proceedings, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to said corporation, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.
